- 2.0 ESSENTIAL QUALIFICATION:- (as on date of issue of notification)- The candidate must have passed 10th class examination or its equivalent (under 10+2 examination system) with minimum 50% marks, in aggregate, from recognized Board and must have passed IT in relevant trade recognized by Government.
- 3.0 AGE LIMIT:- (as on 27.01.2818)- The candidates should have completed 15 years of age and should not have completed 24 years of age as on 27-01-2018. Age relaxation for various categories/community shall be applicable as per rules as amended from time to time.
